1. Identification of the substance/mixture and the company/ undertaking

Trade Name: PCR PP

Material use: Raw material for Plastics Industry
Supplier: FPS Flexibles Romania SRL

2. Hazards Identification

Classification of the substance or mixture

The product is not classified as hazardous according to Regulation (EC) No 1272/2008 and its amendments.

3. Composition/information on ingredients

The product is a polypropylene polymer.

It contains postconsumer recycled polymer.

Based on the information provided by our suppliers the product contains no substance classified as hazardous in concentrations which should be taken into account according to EC legislation.

4. First aid measures

If inhaled: Move to fresh air in case of accidental inhalation of vapours or decomposition products.

In case of skin contact: If molten material comes in contact with the skin, cool with plenty of water. DO NOT remove solidified product, as removal could result in severe tissue damage. Obtain medical attention.

Most important symptoms and effects, both acute and delayed:

Inhalation of dust may irritate the respiratory tract. Prolonged inhalation of high doses of decomposition products may give headache or irritation of respiratory tract.

5. Firefighting measures

Suitable extinguishing media: Water in spread jet, dry chemicals, foam or carbon dioxide. **Specific hazards during firefighting:** Principal toxicant in the smoke in carbon monoxide.

6. Accidental release measures

Vacuum or sweep up spill. All spill of material must be removed immediately to prevent slipping accidents. Recycle or dispose loose material properly. Do not flush into surface water or sanitary system. Should not be released into the environment. It is recommended to implement systems and practices (to prevent accidental release of plastics in to the environment.

7. Handling and storage:

Advice on safe handling: During processing and thermal treatment of the product, small amounts of volatile hydrocarbons may be released. Avid inhalation of dust and decomposition fumes. Provide adequate ventilation. Local exhaust ventilation or additional personal protective equipment (PPE) may be necessary.

Advice on protection against fire and explosion: dust from product represents a risk for dust explosions when dispersed with air in sufficient concentration and with the presence of an ignition source. All equipment shall be grounded. Routine housekeeping will also contribute in preventing risks of dust explosions.

Storage: Safety aspects do not require any special precautions in terms of storage.

8. Exposure controls/personal protection

Do not eat, drink or smoke when using this product. Wash hands before breaks and the end of workday. Appropriate personal protective equipment (PPE) shall be worn in accordance with Regulation (EU) 2016/425.

Provide adequate ventilation. Local exhaust ventilation may be necessary.
